

**Disclosure pursuant to Art. 5 Sec. 1 lit. b) and Sec. 3 of the Regulation (EU) No 596/2014
(MAR) in conjunction with Art. 2 Sec. 2 and Sec. 3 of the Commission Delegated
Regulation (EU) No 2016/1052 – 17th Interim Announcement**

In the period from April 24, 2023 up to and including April 28, 2023, PharmaSGP Holding SE bought back a total of 373 shares of PharmaSGP Holding SE under the share buyback program; on January 3, 2023, PharmaSGP Holding SE disclosed pursuant to Art. 2 Sec. 1 of the Commission Delegated Regulation (EU) No 2016/1052 the beginning of the share buyback on January 4, 2023.

The overall volume of the shares bought back daily in the period from April 24, 2023 up to and including April 28, 2023 and the daily volume-weighted average stock market prices of the shares are as follows:
